VII. CITY MANAGER'S REPORT

Gary Christian questioned the debris pickup and asked if there was an ordinance in place for semi-trucks parking within neighborhood. Chief Hart asked him where he had seen the parking within the city.

Mr. Scott with ESG was asked to look into potholes located on Southland Road. A citizen was questioned about potholes and leaks located at the intersection of Southland and Battle Streets by the Interim City Manager. She said that it was taken care of.

Gary Christian said that the city is looking beautiful.

A male citizen voiced concerns that he had not had his call returned from City Hall and that he had concerns about debris and wiring at 1202 and 1204 North Court Street residences (old Boy Scout foundation). Interim City Manager Burns said that he would contact a volunteer to aid him in moving the debris and would get someone from the electric department to check on the wiring. The department is being expanded with a new employee.

The Interim City Manager also advised members of the meeting that Dennis Hill has a new backhoe and will start clearing some debris and ditches again as are found in West Green Street ditches.
